Included in this would be discussions of expectations for salary, health insurance, pastoral expenses, retirement, vacation time, schooling for children, etc., as well as warnings about the 'hidden' duties of pastors that most cannot see, pastoral burnout/discouragement, and things that have an appearance of worth but in reality waste a great deal of a pastor's time.
