Credential Committee for Thiago McHertt

History

Christ Church Moscow was connected with Pastor Thiago McHertt in November 2021. He was interested in exploring what would be entailed in leading his church, Protestant Reformed Church (PRC) in Joinville, Brazil to become a candidate church in the CREC. Ben Zornes began monthly calls with him to get to know him and learn more about Pastor McHertt, his church, and its history. In Fall 2022, Christ Church sent some representatives to visit the church and meet with Pastor McHertt. The fit with the CREC is a good one and strategic for advancing the Gospel in Brazil.

However, Pastor McHertt has never been formally ordained by a denomination since his church grew out of a Bible Study that he began from a group of believers who were desirous to worship in accordance with Scripture, raising their families in a robustly Christian community, and engage Brazilian culture with the Word of God. Pastor McHertt has faithfully shepherded this small flock for over seven years, and while he has sought out membership in a variety of reformed denominations he has met with a variety of roadblocks. Partially, this had to do with his coming to embrace what might be called CREC distinctives (i.e. postmillennialism, Christian education, paedobaptism/communion, psalm singing, etc.); other difficulties with joining a denomination arose from some miscommunications which led to the church being "left at the altar" with no denominational home.

Credential Examination Rationale

Ben Zornes, along with Douglas Wilson & Toby Sumpter, did an initial "internal" interview with Thiago McHertt to determine whether a full ordination exam or a credential examination would be most appropriate. Our opinion was that, given the circumstances that Pastor McHertt was functionally operating as an ordained minister already, we would do best to examine him as if he was a previously ordained minister (Cf. Article XI.E.1-2). This would allow Knox Presbytery to evaluate whether Pastor McHertt is a good fit as a pastor in the CREC, either receiving his credentials or not. If Knox determined to not receive his credentials, we would not cause an undue disruption to his church. The same might not be said if we were to inform PRC that we don't think their pastor should be ordained. This is not an attempt to lower the bar for CREC ministers, but rather seeks to preserve the peace of a healthy congregation on the other side of the planet by adding our "Amen" to their consent to be pastored by this man.

Examination Results

Thus, Christ Church requested that PM Gene Helsel form a committee to examine Pastor McHertt's credentials. The committee is comprised of Ben Zornes (Chair), Douglas Wilson, Toby Sumpter, & Jefff Rodland. The committee requested that Pastor McHertt supply a reading list from the last 10 years, and one OT & NT exegetical paper. These he provided and we can report that he has read deeply & widely, and his papers were well executed. Since none of the committee members are fluent in Portuguese, and did not receive any pentecostal training in tongues, we recruited some additional help (Pastors Uri Brito & Evandro Rosa, Christ Church Elder Matt Meyer, and layman Joffre Swait) to listen to and evaluate three of Pastor Thiago's sermons (one OT sermon, one NT sermon, and one topical sermon). They provided the committee with their feedback, which can be summarized by saying that although Pastor McHertt is a relatively young preacher, he is a faithful & orthodox expositor, and should of course continue to refine his preaching craft.

On July 28, 2023, the committee examined Pastor McHertt for two hours covering a variety of topics (i.e. personal testimony, family life, systematic & biblical theology, Church history, ethics & cultural engagement, CREC distinctives, etc.). Thiago answered our questions thoroughly and satisfactorily (with a few areas where he could tighten up his knowledge).

Thus, the committee recommends that Pastor Thiago McHertt have his credentials received by Knox Presbytery.

Knox Presbytery,

Three things to report to you for this Spring 2024 meeting, with two actions for you to ratify.

First, many of you will be aware that following our 2023 CREC Council meeting, and the decision of Council to clarify our denomination's practice of sacramental cooperation and reciprocity, Michael Foster's church, East River in Batavia, OH submitted a request for direction to PM of Council Uri Brito. East River and its mission church were received into Augustine Presbytery with the stated exception to our previous sacramental cooperation language, holding to an age-appropriate profession of faith prior to admission to the Lord's Supper, even for visitors or transfer members.

PM Brito consulted with the PMs of the presbyteries, and with our input, responded to East River with the following letter:

"Dear Pastor Foster.

In response to the appeal made concerning East City Church and Silver City Church to grant these two CREC congregations sufficient time to adjust and decide on whether they wish to continue to align themselves with the direction of the CREC--in light of the decision made at Council on sacramental cooperation under Article XIII--the Council responds in the following manner:

"That East River Church and its church plant in Batavia, Ohio, are welcome to remain in the CREC at least until the Council of 2026 in Nashville, TN. These two congregations were admitted into the CREC with their current confessional commitments; therefore, they are not obligated to leave. But at their request, they would like to take this time to consider complying with our new changes or leaving the CREC."

We are grateful for your labors and contributions to the CREC and pray that this season will be

fruitful to both congregations as they consider how best to proceed.

Rev. Uriesou Brito, Presiding Minister of Council January 23, 2024

There is no action on this, and there may be more to discuss amongst ourselves. I will only note here that I have been arguing that it would be very poor form for the CREC to require East River to leave over this matter. While there has been some reticence to formally "grandfather" East River and its mission church into the CREC (not wanting to create a precedence), I have been pressing us to adopt a stance that includes the language that since they entered with these stated exceptions, they are under no obligation to leave.

Second, back in January, friends in Brazil came under fierce opposition for inviting Doug Wilson to speak at a large conference there. I was asked to write a letter in support of Doug Wilson's character and ministry, and I did so. The invitation was ultimately rescinded, citing security concerns. I do not know if/when my letter was used in the process, but the letter is attached. I would appreciate your ratification of that action.

Finally, Christ Church Moscow requested the formation of a credentials committee for Joe Rigney. I appointed Jared Longshore as the chair and he formed the committee reporting today. I also request your ratification of that action.

To Our Brothers and Sisters in Brazil:

Grace and peace to you from God our Father and our Lord Jesus Christ.

I am writing in my role as the Presiding Minister of Knox Presbytery, a presbytery of the Communion of Reformed Evangelical Churches, a presbyterian denomination of protestant and reformational churches. All of our churches subscribe to the Apostles' Creed, the Nicene Creed, and Definition of Chalcedon, and affirm at least one of the standard Protestant Confessions of Faith such as the Westminster Confession, Heidelberg Catechism, or Belgic Confession (among others). The CREC is an international denomination with churches in North America, Europe, Asia, and South America, including one member church as well as a mission church in Brazil.

I am writing because it has come to my attention that with one of our ministers, Pastor Douglas Wilson, coming to speak at a conference in Brazil in February, questions and concerns have been raised about Pastor Wilson's orthodoxy as well as certain controversies that have arisen in his church, Christ Church of Moscow, Idaho. With regard to Pastor Wilson's orthodoxy, our denomination examined him in 2004, at his request, regarding matters such as justification by faith alone, and he was found to be fully orthodox and within the bounds of our Protestant confessions. That exam is publicly available under Pastor Wilson's "Controversy Library" on his personal blog: dougwils.com.

Likewise, over the course of his ministry of many years, several very difficult pastoral situations have arisen at Christ Church, including instances of child and marital abuse. While those situations were dealt with biblically and lawfully, numerous detractors have slandered Pastor Wilson and Christ Church accusing them of covering up abuse or worse, actually defending it. Pastor Wilson has also answered these charges in his "Controversy Library," but at the request of Christ Church, the CREC also conducted its own investigation of the handling of the most significant abuse cases and found "no evidence that the leadership of Christ Church sought to protect abusers from the legal consequences of their actions." The report further affirmed that "law enforcement was involved promptly once the allegations became known..." And it states, "In the entirety of our review of the cases, we found no gross moral failings on the part of the leadership of the church." The full CREC report is available under "Documents" at crechurches.org.

I hope that this letter addresses the questions and concerns raised by some. It is the official position of Knox Presbytery and the CREC that Pastor Douglas Wilson and Christ Church are safe, healthy, and fully orthodox, and I commend them to you.
